## *RESPONSIBILITIES*

What are the Family Self-Sufficiency Participant's obligations?

- Participate in an assessment of present skills and explore career options.
- Agree to pursue education and/or job skills by participating in a program as needed.
- Participate in recommended assessments, interviews, tests, evaluations and workshops.
- Play an active role in developing and implementing an Individual Action Plan.
- Seek and maintain suitable employment.
- Comply with the terms of the lease agreement with the Springfield Housing Authority.
- Provide information concerning wage increase in order to begin escrow account.
