We will have to reapply in January of 2023.

The Modernization and Development Department has identified Central Illinois Security, Inc. as responsive to the RFP with a contract cost of one hundred thirty-one thousand six hundred and sixty-five dollars and zero cents (\$131,665.00) to install security camera systems at five (5) scattered site properties located in AMPs 1 & 2. The contract end date is 120 days from the start date as stated in the Notice to Proceed letter.

DISCUSSION: Melissa gave an overview of this resolution. The United States Department of Housing and Urban Development issued PIH Notice 2022-11 requesting applications from eligible public housing authorities to voluntarily participate in the Moving to Work Demonstration Program. The Springfield Housing Authority meets the minimum criteria The SHA publicly posted its intent to submit a Moving to Work Application from Monday, June 13, 2022, through Thursday, July 14, 2022, and held public meetings on July 7, 2022, for opportunities for additional residents and public comment. Moving to Work (MTW) is a demonstration program for public housing authorities (PHAs) that provides them the opportunity to design and test innovative, locally designed strategies that use Federal dollars more efficiently, help residents find employment, and become self-sufficient, and increase housing choices for low-income families. MTW allows PHAs exemptions from many existing public housing and voucher rules and provides funding flexibility with how they use their federal funds. In the plan, we will serve 50 program participants to help increase credit scores.
