PREFERENCE (**25 POINTS**) IS GIVEN TO THOSE WHO HAVE BEEN EMPLOYED IN SANGAMON COUNTY FOR THE LAST TWELVE (12) MONTHS OR IF YOU RESIDE IN SANGAMON COUNTY AND ARE UNABLE TO WORK DUE TO A DISABILITY. IF YOU QUALIFY FOR THIS PREFERENCE, BRING VERIFICATION OF EMPLOYMENT OR VERIFICATION THAT YOU ARE UNABLE TO WORK DUE TO A DISABILITY.
